Lub Xeev thiab tsoomfwv tsab kev cai lij choj puav leej qhia txog qhov yuav tsum muaj txhawm rau muab cov kev ntsuas txog tus cwj pwm thiab cov kev pab cuam. Daim ntawv no muab qee cov ntsiab lust seem ceeb rau koj ntsig txog cov kev cai lij choj thiab muab cov ntsiab lus rau koj hais txog koj tus menyuum cov cai ntsuas kev coj tus cwj pwm zoo, kev qhia ntawv thiab cov kev pab. Daim ntawv kuj tseem qhia rau koj txog koj tuaj yeem tau txais kev pab txawb yog tias koj xav tau nws lossis yog tias koj muaj lus nug txog qhov hloov pauv ntawm tsab kev cai lij choj.¹

Yog koj tus menyuam muaj cov cwj pwm uas muaj qhov puas tsuaj rau koj tus menyuamm lossis lwm tus menyuam li kev kawm paub, tsoomfwv tsab kev cai lij choj tau teev tseg tias pab pawg IEP YUAV TSUM txiav txim siab seb yam kev pab txhawb coj tus cwj pwm twg thiab yam phiaj xwm thiab lwm yam kev pab twg uas tus menyuam xav tau yog li ntawv koj tus menyuam tuaj yeem tau txais cov kev pab los ntawm qhov chaw kawm hauv qhov uas tsis muaj yej yam kev txwv ntau. Sec. 300.324(a)(2),(b)(2).] Lub tsev kawm hauv nroog yuav tsum tau muab hom kev ntsuas, kev npaj, kev pab lossis kev pab txhawb uas koj tus menyuam pab pawg IEP txiav txim tias yog cov tsim nyog pab rau ko tus menyuam tus cwj pwm hauv tsev kawm ntawv yog li koj tus menyuam tuaj yeem tau txais txiaj ntsig los ntawm qhov kev kawm thiab tsis tas yuav tsum rhais chaw mus rau lub tsev kawm uas muaj qhov txwv, xws li chav kawm hnuv tshwj xeeb lossis qhov kev pab kho, vim qhov koj tus menyuam muaj cwj pwm tsis zoo.

2. Kuv yuav ua li cas kom paub tias kuv tus menyuam tau txais yam kev ntsuas koj tus cwj pwm thiab cov kev pab raws li qhov xav tau?

Yog tias koj tus menyuam muaj tus cwj pwm tsim kev puas tsuaj rau koj tus menyuam li kev kawm lossis lwm tus menyuam rab peev xwm kawm, koj yuav tsum tau sau ib tsab ntawv thov kom muaj lub rooj sib tham IEP txhawm rau txiav txim siab yam kev pab txhawb thiab kev pab cuam uas koj tus menyuam xav tau txhawm rau hloov tus menyuam tus cwj pwm mus rau qhov zoo. Cov kev pab uas pab pawg IEP yuav tsum tau txiav txim siab suav nrog cov ntsiab lus teev tseg txog qhov kev ntsuas tus cwj pwm, qhov kev npaj pab txhawb tus cwj pwm thiab yog tias tsim nyog, qhov kev npaj pab hloov tus cwj pwm mus rau qhov zoo, kev pab hloov ib qho cwj pwm zuj zus, qhia kev paub rau niam txiv thiab/lossis kws qhia ntawv thiab kev sab laj nrog tus kws tshaj lij kho koj cwj pwm, tus kws sab laj, tus kws muaj txuj ci pab cuam tib neeg, cov phiaj xwm tswj hwm kev npau taws thiab lossis lwm yam kev pab uas koj ntseeg tias koj tus menyuam xav tau.

Ua ntej lub rooj sib tham IEP, koj kuj yuav tsum tau sau ib tsab ntawv thov kom ntsuas kev koj tus cwj pwm, tshwj xeeb yog tias lub tsev kawm ntawv tau txhim kho qhov kev npaj pab txhawb tus cwj pwm lossis tau siv lwm yam phiaj xwm koj tus cwj pwm uas tsis ua haujlwm txhim kho koj tus menyuam tus cwj pwm nyuaj. ntawm tus cwj pwm, nws nquag tshwm sim npaum cas, nws tshwm sim ntev npaum cas, nws tshwm sim nyob rau qhov chaw twg, thiab muaj dab tsi tshwm sim ua ntej thiab tom qab koj tus menyuam koom nrog hauv kev hloov tus cwj pwm thiab koj tus menyuam ib puag ncig chaw kawm paub txhawm rau pab cuam pab pawg IEP txiav txim siab tias vim li cas koj tus menyuam thiaj koom nrog hauv tus cwj pwm nyuaj thiab dab tsi uas tuaj yeem ua tau txhawm rau pab koj tus menyuam hais daws qhov no. Lub Chaw Haujlwm Saib Xyuas Qhov Kev Kawm Tshwj Xeeb (Office of Special Education Programs (OSEP)) tau piav qhia txog kev ntsuas rab peev xwm coj tus cwj pwm xws li “cov kev ntsuas” raws li IDEA. Yog li ntawv, koj yuav tsum hais qhia lub tsev kawm hauv nroog tias thaum koj thov qhov FBA, txhua yam yuav tsum ua raws kev cai uas siv tau rau lwm qhov kev ntsuas.²

3. Thaum twg lub tsev kawm hauv nroog thiaj tuaj yeem siv cov kev pab cuam qhia koj tus cwj pwm xwm txheej kub ntxhov xws li ua kom txhob npau tawv cev lossis txhob ntxhov siab dhau rau kuv tus menyuam?
